Further development into a provider of full-service solutions. Start-up of production and secondary packaging site Ravensburg-Mariatal.

2010s

Opening of first international clinical production facility in Chicago, IL, USA. Start of Center for Visual Inspection and Logistics in Ravensburg-Erlen. Opening of sales offices in Japan, Singapore, and South Korea.

2020s

Expansion of Development Services with new location in Rankweil, Austria. Opening of Vetter training centers. Turnover > 1 billion Euros.
